THE MEDICAL CLINIC PROVIDED FREE PRIMARY CARE TO 850 INDIVIDUALS IN 2012. THERE WERE 2,373 PATIENT VISITS TO THE MEDICAL CLINIC AND CARE WAS PROVIDED BY VOLUNTEER HEALTHCARE PROFESSIONALS INCLUDING PHYSICIANS, NURSE PRACTITIONERS AND PHYSICAL THERAPISTS. THE ESTIMATED VALUE OF THE MEDICAL CARE PROVIDED TO PATIENTS IN 2012 WAS \$672,000. THE CLINIC ALSO HELPED 56 PATIENTS APPLY FOR FREE MEDICATIONS TOTALING 169 MEDS THROUGH "NEEDY MEDS" PROGRAMS OFFERED BY PHARMACEUTICAL COMPANIES SO THAT PATIENTS RECEIVED \$103,686 VALUE IN MEDICATIONS FROM THE PHARMACEUTICAL COMPANIES.
